Agreement

- I understand that the minimum group size for a complimentary bus is 45 passengers per bus for buses that can carry up to 55/56 passengers. Groups that do not comply with the minimum group size criteria, regardless of contributing factors, will be charged \$25 per passenger short of the minimum, to the credit card posted on Page 2 (group size refers to actual number of passengers on Casino Report), and that a charge of \$250 per bus will apply to groups arriving at the Casino after 5:00 PM on Saturdays;

- I understand that all passengers must be 19 years or older, and must carry a government issued photo ID. Examples are as follows: For Canadian residents: driver's licence, Canadian citizenship or passports. For U.S. residents: driver's license, and passports. For visitors to Canada: passports. The bus driver has been authorized to refuse boarding to any passenger without a valid identification document. A penalty of \$1,000 will be charged to the credit card posted on Page 2 for every underage passenger on board the bus;

- I understand that the bus driver has been instructed to depart from the pick-up location at the approved departure time, and if the Casino is unable to accept the charter group because the bus has missed the allocated arrival time, a penalty of \$850 per bus will be charged to the credit card posted on Page 2;

- I understand that my group has to stay a minimum of 5 hours in the casino, and that a delay in the bus arrival time at the casino, regardless of contributing factors, will result in a later departure time from the casino to accommodate the minimum 5-hour stay requirement; otherwise, a penalty of \$850 per bus will be charged to the credit card posted on Page 2;

- I understand that passengers will not be sold, served or permitted to consume beverage alcohol on board the bus; and that it is not permitted to have gambling activity on the bus;

- I understand that if the group cancels or requests for a travel date change within 7 days of departure, a fee of \$500 per bus will be charged to the credit card above. If the group cancels or requests for a travel date change within 24 hours of departure, a fee of \$850 per bus will be charged to the credit card posted on Page 2. There will be no penalties for cancellations or changes prior to 7 days of departure;

- I understand that I must have available funds of at least **\$1100** on the credit card submitted on Page 2, as DSL Travellers' Tours will be putting a hold of the said amount on the card to be used against any fees and penalties as aforementioned. I further understand that this hold will be released after the arrival of the group when it is established that the group has satisfied all charter conditions;

- I understand that a security deposit of **\$250** will be charged to the same credit card to cover eventual expenses for special cleaning services or bus damage caused by members of your group. Said deposit will be re-credited to the credit card on the first working-day after the travel date of your group if no such special expenses are necessary;

- I have read and understood the conditions on Pages 3 and 4, and agree to assume the responsibility of enforcing the above as Group Leader and in full representation of my group;

- I understand that my request is not considered confirmed, until I have received written confirmation (email, fax, or letter) from DSL TravellersøTours.
